...Being renowned political figure and former journalist, the abductee had been involved in the rightist political group, Hanmin Political Party. There were many witnesses to his abduction, but there was a man named Mr. Lee, Wan-gu, in particular, who lived in the same village with the abductee and had been very close friends since their childhood. As the war broke out, the abductee was arrested and released after three days for the first time. Nevertheless of Mr. Lee's advice on escape, the abductee choose to remain at his residence, thinking he was convinced of innocence. Then the agents of the North Korean Political Security Bureau, which had ready in hand a list of target people, abducted him on the street near his residence on July 17, after they found material connected to his activities. No information, whatsoever, since then....

.....The North Korean Political Security Bureau under the instruction of the North Korean regime. It is obvious that the regime already had a certain instruction to abduct South Koreans, with prepare lists of South Korean elites, several hundred of thousands, from which it selected final target persons needed for not only for justifying its regime but also to use them for various purposes....

...Mr. Lee, Wan-gu, who lived in the same village with the abductee and had been very close friends since their childhood. And anonymous group of friends and fellow journalists who no longer are alive. Also Mr. Lee, Tae-young, the abductee's son (born in 1941), is the indirect witness of the abduction.....

(i) Additional Information on the case. Please indicate any other relevant information that could be useful to find the person

<u>The abductee was a renowned politician and journalist who was involved in the Dong-a Daily's "Blacked-out</u> Japanese Flag Incident" when Korea was under the Japanese ruling. He removed the Japanese national emblem on the chest of the 1936 Olympic marathon champion Son Gi-jeong, in the photograph for the newspaper article. Besides, he was indirectly involved in the nationwide Independence Movement on March 1st, 1919, before he became a journalist.

<u>His role was transporting leaflets for the Interim Government, for which he was arrested and imprisoned for the first time, followed by five more various activities for independence movement. He was reinstated by Dong-a Daily, after liberation of Korea. He was a forerunner in sports filed; Standing Director of the Cho-sun Sports Association, Vice Chairman of the Baseball Association, and founder of Korean Athletic Club. He was involved in several major athletic competitions and organization, directly or indirectly. Before his abduction, he was compiling "The History of the Korean Sports", without completion.</u>

The abductee later became a member of Hanmin Political Party (Korea Democratic Party) where he had been possibly involved in Anti-Trust Movement. He also served as a member of National Conference engaged in preparation of establishing the first Korean government along with other nationalist leaders, and at the same time he was working to create Hanmin Political Party as its deputy-organizing director

(a) Complaints (when, by whom, and before which organ/s)

In 2006, the testifier claimed for compensation against Korean government, along with other members of KWAFU(Korean War Abductees' Family Union) whose abducted families were then government officials. They accused ROK government of dereliction of its duty to protect its nationals at the time of Korean War. The compensation has not been made yet.

(b) Other steps taken (when, by whom, and before which organ/s)

i) There happened to be a North Korean espionage, Lee Su-geun, a former North Korean journalist. He was questioned for details of the abductee's whereabouts only to fail. Some international organization agents travelling to Pyeong-yang were as well questioned, again to no avail. Recently, the abductee's family requested Mr. Chung Dong-seong, former minister of Sports Ministry, to look into this matter with an official letter, again to no avail

ii) On June 25-Aug 31, 1964, the Chosun tribune newspaper and Korean National Red Cross collaboratively carried out a "One million signature-collecting campaign for Korean War Abductees' Repatriation", and it was submitted to the United Nations, but turned down because the wartime civilian issues were deemed to fall under the jurisdiction of the International Committee of the Red Cross.

iv) Dec 13, 2011, KWAFU advocates the drafting and passing of House Resolution 376, a U.S. congressional

House resolution.
